# DECLARATION

- My request for the parking permit is based on the conditions regulated in the decrees "Budapest Főváros Közgyűlésének 30/2010. (VI.4.) rendelete" and "Belváros-Lipótvárosi Budapest Főváros V. kerület Önkormányzata 31/2008. (XI.19.) rendelete"
- I declare under penalty of perjury that, at the time of handing in my application, *according to the records of any and all parking operators in Budapest* with regards to the vehicle for which I request the permit for, I do not have any unpaid and undisputed parking penalties older than 30 days.
- <u>I understand and accept that an incomplete request form, missing mandatory attachments</u> as well as parking penalties will exclude me from obtaining the permit.
- I undertake to report the loss, theft or destruction of my parking eligibility sticker within 5 working days to the issuing body (Customer Service Desk of Belváros-Lipótváros Közterület-felügyelet) and submit a new request for parking permit.
- I undertake that if during the validity of my permit I sell or deregister the permitted vehicle, change its registration number, or change my registered permanent address, I will return the parking eligibility sticker within 5 working days to the issuing body (Customer Service Desk of Belváros-Lipótváros Közterület-felügyelet).
- I will affix the eligibility sticker to the permitted vehicle's front windshield so that it can be clearly seen and checked from outside.
- I, the undersigned, declare under penalty of perjury that all the information provided in my application is complete and correct.
- I give my consent to Belváros-Lipótváros Közterület-felügyelet to contact me on my email address with important information, notices or options on how to renew my permit.
- I give my consent to Belváros-Lipótváros Közterület-felügyelet to handle my data according to GDPR of the European Union.
